# WARM 101.3 "MATCH & WIN" CONTEST

Official Contest Rules

## 1. How to Enter the Contest:

- a. The WARM 101.3 Match & Win Contest ("The Contest") will begin on 4/16/12 and end approximately on 5/4/12, or when all prizes have been given away to contestants.

Station may elect to call additional times at will. The 20<sup>th</sup> caller will play The WARM 101.3 Match & Win Contest by picking two squares identified by the numbers 1 through 32.
